• New Committee Member

Jill has declined to come back on committee. Diana will email the membership and ask for nominations for a new committee member. A vote will be held if needed.

• Agility Equipment Standardisation

Donna applied for a grant from DNZAC to modify our second set of gear but the application has been declined.

Non-members at Training Rule Change

Jim Reay has proposed some wording changes for our Rules.

Allowing non-members at training would have a significant impact on all members, not just those seeking the change, and therefore all members should have a say in the matter. Policies will need to be put in place to ensure this does not have a

detrimental effect on members or on the club. It was agreed that the proposed rule changes and accompanying policies should be presented to the membership for discussion, followed by voting at a Special General Meeting.

Elaine will go back to the Obedience members to update them.

PO Box

Diana went in to try and cancel the PO Box but needed a letter from the club to say it was to be cancelled. Both keys need to be handed in. Apparently they will just hold our mail in the meantime. It will be \$130 to get our mail re-directed for two months as we count as a business. It was decided that we did not need to redirect the mail as only three organisations ever send us anything. The mailing address will be changed to the Secretary's home address. Dianne will contact Westpac about cancelling paper statements and to see if term deposit statements can be downloaded. Diana will notify DogsNZ and Crombie Lockwood, and make changes to the address on other platforms as needed.

Photography Policy

A note has now been added to the online entry options for all the September shows, stating that completing the entry form indicates that the person agrees to OCTC taking and using photos and video of them for use on the OCTC website and social media accounts, and asking them to contact the show secretary if they want to withhold permission. This is probably the most practical option for non-members entering our shows. There is also now a mandatory yes/no field on our online membership form asking if permission is granted. This will capture everyone who fills in a membership form at some point, although quite a few people still don't fill in a form when renewing or joining, including Foundation people.

The committee is happy with this solution. It is not anticipated that many people will withhold permission and so this should be manageable. It was felt that CC people were a different matter and that in general no photography would be permitted. If there was a special reason for needing photos or videos, those involved could be asked individually and forms signed.

Coordinator Reports:

• Agility (Belinda Culling) (Melissa/Jean)

Agility continues at EC. Trainers this round are MaryRose, Anne and Donna. Sorry I have no idea about new numbers coming in – Adele may have this info if required.

Leigh has now taken over from Adele again. She is hoping to organise a instructors' workshop to get a few more people ready to take classes.

• Canine Companion (Lynn van Beers) (Lynn/Melissa)

Week 6 graduation night was last week. We had a large number of retained handlers disperse through the sports and also into CC2.

One of these handlers has approached me, as she has been turned down for joining Agility. She asked to start upon completion of CC1 and was turned down; she asked again upon completion of CC2 and was still turned down. Why is she being turned down? The dog and handler are both brilliant, the dog is now 8 months old. At the first committee meeting back in January/Feb I'm sure it was announced that Agility would take dogs from 6 months of age and have a special class to allow for them, as at that time, as Coordinator, I spoke with Leigh and pointed out that the age group of 6-12 months is the majority of CC dogs, and if Agility wants to be fed from CC, this is the age group involved.

I have currently limited the CC1 class due to start 22nd Sept-27th Oct to only 10 dog/handlers instead of a split class involving 20 dog/handlers, with another approx 10 CC2 dog/handlers on top.

The skeleton crew of CC trainers are close to burn out. Bringing it down to one class means I can somewhat rotate them to get a break from the endless 30 dog turnover every 6 weeks.

This of course will result in a very large loss of income. I will relook at going back to double classes if more trainers are prepared to come on board and help. It needs to be remembered that the trainers doing CC are doing this workload on top of also being trainers for their own chosen sports.

• Obedience (Diana O'Kane) (Ailsa/Jean)

Ailsa and Diana started a six week foundation Competitive Obedience course last Tuesday. We only have three dogs - one experienced handler and two "off the street". One Senior has also been attending to do her own thing. Five CC people who had expressed interest were contacted – two declined due to other committments, two are already doing Agility and can't attend both, and one did not respond (Lynn has contacted him as he may have missed the message). We would really like to have more people attending - being on a Tuesday is a problem due to the clash with Agility and a different night would be preferable. CC demos need to be pitched at a suitable level so it looks fun but achievable.

• Rally-O (Elaine Limburg) (Elaine/Melissa)

I have changed the length and timing of rally courses. The next two are 4 weeks, one starting 12th July to 2nd August inclusive. Then a break week on 9th August. Next course starting 9th August to 6th September. A mock competition night on 13th September, the Monday before our Dogs NZ rally event.

The change in course length means people are not parting out quite so much money and the CC people do not have so long to wait before a course is available.

Some people are taking a break over the worst of winter but numbers are fairly consistent at 21.

Elaine raised the issue of confusion over the non-member training surcharge for Foundation courses. Diana will look at drafting an invoice that could be sent to Foundation people to try and reduce the information overload and clarify what they are to pay.

• Treibball (Ailsa Hawkins) (Ailsa/Elaine)

A tournament is scheduled for the 23rd July. There are a good number of beginners who are sticking with it and everything is progressing nicely.

• Flygility (Elaine Limburg) (Elaine/Melissa)

We have not had a training session recently due to the weather and ground conditions. I am keeping people informed and the next training session is 31st July.

• Forrester Park (Dianne Sprott)

FPMC are reviewing show hire fees with a view to implementing fair increases.

It was noted that clubs are being charged on a week-by-week basis up until August (ie if hall not used, no fee), after which bookings which were ongoing would be charged regardless.

Elaine moved that OCTC pay Forrester Park for every Monday/Tuesday/Wednesday/Friday (except pre-breed show) night, regardless of scheduled or unscheduled breaks. Seconded by Ailsa. Passed 6 for, 1 against.

The committee has already agreed that this would be the case – this motion is to formalise that.

Club Dollars

What information is required for club\$? This was quite time consuming to add up etc. Even after saving the spreadsheet from the website, I couldn't edit it, so had to manually work everything out.

YTD info is actually only to end of June, so the few issued/spent in July are not included.

This is very useful information. Although they do potentially represent lost income to the club, it was noted that a significant proportion of club dollars given out are never used. The people who are earning them are generating significantly more income for the club than they are being "paid", so any loss to the club in non-cash entries and training fees is still much, much less than the income being brought in. If they aren't able to use club dollars, those people would not necessarily enter as much or attend as much training, so there is not a direct correlation between use of club dollars and loss of income, and we may lose instructors if there is less incentive to take a class.

• Age for Agility Classes

On the judging contract they were offered a billet, but declined, saying they would organise a motel. Carole had confirmed with Melissa that this wouldn't cost the club extra; Isobel has said she made a mistake on her contract in not including that expense. Email Issues
